Annual Report for the 2019/20 Academic Year

Now in its 32<sup>nd</sup> year, Project Lifeline continues to provide support to young men and women who have a history of involvement with the Cook County Juvenile Court. This support consists not only of financial assistance but also mentoring and academic tutoring. For many of these students pursuing a post-secondary education is the only route to escape the poverty, community violence and other adverse circumstances they live with every day.

Project Lifeline's unique public/private partnership with the Cook County Juvenile Probation Department continues to be a unique facet of the program. **The volunteer Probation Officers who serve as mentors to the participants provide emotional support and encouragement, which is crucial, especially since most of our students are the first in their family to attend and graduate from college.**

Over 150 recipients have graduated from community colleges, traditional four-year colleges, universities, and professional certification programs. These remarkable young men and women have, through their achievements, demonstrated the efficacy of the Project Lifeline approach. **The accomplishments of these students have been fueled by the financial support that Project Lifeline has provided with tuition, books, computers, housing, tutoring, and mentoring.** Even with the challenge of the COVID-19 pandemic, 9 of our students earned degrees and certificates this academic year.

The student who earned his Associates Degree from Oakton College did so with a **4.0 GPA**. He is currently a student in the Honors Economics Program at Northeastern Illinois University.

The student who earned her Associates Degree from Fox College in Dental Hygiene has received her state certification in that field and is **now working as a Dental Hygienist**.

The student who **earned her state certification in Sonography Principles and Instrumentation** is continuing in the highly competitive MRI program at Triton College while pursuing her goal to become a technician in that field.

### **Financial Review:**

From June 1<sup>st</sup> 2019 to May 31<sup>st</sup> 2020, Project Lifeline spent \$189,907 on behalf of 48 students. Included in this amount was \$7,688.00 for tutoring. For the sixth consecutive year Project Lifeline sponsored a five-day Writing Workshop for our new students. This program is run by the Roosevelt University Writing Department and staffed by their faculty and student writing coaches. The program is designed to enhance the specific writing skills that our new recipients will need to meet the demands of college level work. This year, the program was run virtually. The cost was \$5,500. Once again, administrative costs for Project Lifeline were held to 2% of total expenses.

### **Projected Budget for the 2020/21 Fiscal Year:**

For the 2020/21 academic year Project Lifeline has budgeted \$260,000. This will be allocated for 36 returning students and 26 new recipients.

The generosity of Project Lifeline donors provides us with the ability to fund these scholarships. With the assistance that Project Lifeline provides, these students continue to inspire us with their ability to overcome the daunting obstacles in their path and achieve educational success.
